Advisory to Council	The group has no decision making powers. Group provides a recommendation to the Council for consideration.
Advisory to CEO	The group has no decision making powers. If it is seen as though tasks are undertaken as a result of a discussion at a meeting, it is because the CEO has power to act within the financial capacity of a decision of Council, the ABP, Annual Budget and/or Council policy. The CEO is not directed by the meeting, but may utilise the meeting for information and/or as a sounding board for ideas.
Liaison Position	An Elected Member attends an external Committee and communicates back to the Council on that groups business.
Local Government Association (LGA)	Delegate/Deputy Delegate empowered to vote on behalf of the Council
